



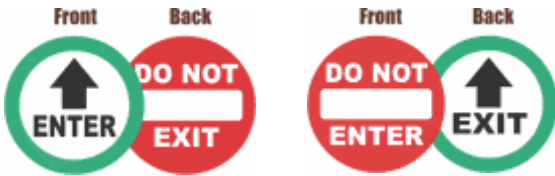

## Special Announcement Memo

The Special Announcement Memo below was created by one of our customers several years ago. It seems to work very nicely in new installations.

## Special Announcement

Your safety and the safety of this (Bank, Credit Union, etc.) staff is of the utmost importance to the (Name of Bank, Credit Union, etc.). To help ensure your safety the (Bank, Credit Union, etc.) will be installing a new Weapons Control System at the front entrance.

☐ The system is made up of an Entry Lane and Exit Lane.

☐ Each Lane has an Entry and Exit door.

☐ The Entry and Exit doors of each lane are interlocked so that both doors cannot be unlocked and opened at the same time except in an emergency.

☐ The Entry Lane also includes a metal detector to prevent unauthorized persons from carrying weapons or excessive metal into the branch.

All members and (Bank, Credit Union, etc.) staff will enter and exit through the new access control system, therefore, we ask that everyone please take a moment to familiarize yourselves with the following procedures so that your first experience with the system will be a smooth one.

### To Enter the Branch:

Follow the visual prompt mounted near the final entrance door as you pass through the Entry Lane.

☐ Open the door to the right-side Entry lane marked with an Entry (arrow) and enter.

☐ The entry door will close behind you as you step through the metal detector.

☐ If no weapon or excessive metal is detected the final entry door will unlock and you may enter the lobby area.

If a weapon or excessive metal is detected, an alarm will sound and the red light will turn on. At this point you will have the following options.

☐ Step back through the detector and try again.

☐ Leave the Entry Lane through the entry lane door.

☐ Wait for and authorized person to override the alarm. You may use the intercom within the system to request assistance. You may be requested to return the object to your vehicle before re-entering the system.

If two persons wish to enter the (Bank, Credit Union, etc.) together, each must first successfully pass through the metal detector. The final entrance door will remain locked until the second person passes through the detector and is standing with the first person near the final entrance door. Again please follow the visual prompts. Please not that as long as anyone (or anything) has not passed through the detector, the final entrance will not unlock.

### To Exit the Branch:

As you exit from the lobby, use the right side Exit Lane market with the exit arrow.

☐ Open the door, step inside the Exit Lane.

☐ Walk toward the exit door.

☐ As you approach, the exit door will unlock.

If you need to re-enter the building, you must return through the Entry Lane.
